AUXDATA Training Status Unit Report

The Training Status Report shows all of the currency maintenance tasks required to stay current and the date the task must be completed. This is one of the canned reports available from AuxData showing valuable and timely information regarding the member's qualification.

The report will show in detail your qualification status (Not Certified, Qualified, REYR, REWK and ADMIN) workshop requirements and number of hours, exams and visits required in each qualification to keep you current.

Because of the high number of members that went into REYR last year I'm guessing that some of this information was not passed down. Starting in 2009, I will be forwarding this report to the Division Board and staff along with all the FC's and VFC's on a monthly basis. Please forward it directly to your members.

The report primarily utilizes color to convey your qualification status.

Generally the colors can be summed up as follows:

GREEN = Qualified

BLACK= Qualified, previous year tasks completed but current year tasks not yet completed **RED** = Previous and current year tasks not completed

If you see your qualification in RED it will be followed with one of the three reasons defined below:

REWK

Certification lapsed because of failure to complete a required workshop (AUXDATA is updated in early July and those not listed as having completed required workshops are set automatically to RE-instate workshop needed).

REYR

Certification lapsed because of failure to complete required currency maintenance (AUXDATA is updated in early Jan and those not listed as having completed required currency maintenance tasks are set automatically to RE-instate Your Requirements) The date you went into REYR will be displayed just below the qualification.

NOT CERTIFIED = Not all the task(s) are complete. A great example is AUXOP qualification. The courses you completed are in green and the courses to be completed are still in RED.

ADMIN= Directors office has a hold on the qualification.

EXAMPLE 1 – AUXOP – Person is not certified because all courses are not complete. Items in RED need to be finished.

The reason for the lag is the manual intervention required to fix the issue by many people. It is far better to NOT let yourself get into trouble.
